Ash Hartwell has forty years of field experience working at community, national and international levels on educational policy analysis, planning and research. He has provided technical assistance and training for the establishment and strengthening of national educational planning divisions in Egypt, Botswana, Lesotho and Uganda. He has provided leadership in establishing innovative designs for basic education reform in Egypt, Ghana and Malawi, and the development of a health oriented rural women's literacy program in Afghanistan. Ash has been the Team Leader for numerous program and project evaluations in fields of basic education, youth assessments, and higher education. He has also held regular and honorary teaching positions in several universities in Africa and the United States.

(Now **Adjunct**) **Professor, Center for International Education, University of Massachusetts** and since 2000. Design and conduct courses on education policy; costs and financing; monitoring and evaluation in development; application of learning principles to program design; alternative and complementary basic education; and education in post-conflict regions.
