Bibliography with Search Terms: 1996 – June 2010

This bibliography with search terms contains a record of books, articles and other materials related to empirical studies of fraternity and sorority members and fraternity / sorority life. The time frame included in the bibliography was from January 1, 1996 to June 30, 2010. Other research references including annotations are available from the Center for the years 1950-1970, 1970-1980, 1980-1985, 1986-1995).

The present bibliography was compiled by master's graduate students in the Master of Science in College Student Affairs program at Eastern Illinois University. The bibliography of nearly 500 items was generated using standard library search engines available in Booth Library at EIU, including EBSCO, Academic Search Premiere, Dissertation Abstracts, and other available engines at the time. Use the search and find function of Microsoft Word to search for listings under each search term.
