Dear Brothers:

Poor black sisters decide for themselves whether to have a baby or not to have a baby. If we take the pills or practise birth control in other ways, it's because of poor black men.

The legal progression of access to reproductive healthcare can largely be attributed to the interest convergence of eugenicists and the opportunity to enforce birth control as a tool to limit the reproduction of populations that they find undesirable. This can be recognized in United States law as it continually challenges and denies the right to access birth control, while at the very same time its prisons weaponize birth control methods to

Eugenics:

The pseudoscientific belief that it is possible to perfect the human race and to create an 'ideal' person. This is executed on a systemic level to "improve" entire populations.

In both practice and theory, eugenicists refer to ableist, anti-Semitic, classist, ethnocentric, racist, and anti-LGBTQIA standards of "ideal", and rely on atrocious methods to limit the reproduction of certain grouns through forced compulsory sterilization

Reproductive Healthcare:

Abortion is a personal choice to terminate a pregnancy made by an individual who has autonomy over their body.

A person may choose to terminate a pregnancy because they lack the resources, community, psychological or physical capacity; the fetus may be predicted only to live a few months, or to be addicted to drugs; or, for any other reason that owes no

HISTORY

Cocial Darwinism

Charles Darwin and Francis Galton coined the term "Eugenics" in 1880's England to describe an ideal society through selective breeding.

he American Breeders Association (1903)

- Created in order to begin research on how to implement eugenics in the United States.
- (1911) John Kellogg created the Race Betterment Foundation along with other less notable foundations whose goal was to research breeding patterns within families in order to uncover how certain traits were

World War I (1914-1918)

 The idea of eugenics reached countries around the world as they began to ponder what the "ideal" person should look like

The American Eugenics Society

- Meant to educate the American public on what eugenics would do to a society.
- Considered abortion to be murder.

World War II (1939-1945)

 Catastrophic Nazi rulership in Germany relied on eugenics theory to justify the state-sponsored extermination of six million Jews, as well ethnic and racial minorities, people with disabilities, and those who were a near

The Indian Health Service (1960s and 70s)

- Documented by Jane Lawrence
- Indigenous women seeking healthcare, such as a tonsillectomy, were being sterilized without their consent or knowledge
- At times, they were lied to and told that tubal litigation was reversible.

LEGAL THEORY & COURT

- "Feeble-minded, moron theory" untair tests by
 psychologists in the early 1900s were constructed to
 conclude that immigrants and prisoners in the U.S. had
 low IQs, manufacturing a correlation between
 "feeblemindedness" and criminality.
- Suggests that chiminality and report informers is hereditary and that such "defects" could be distinguished along racial and ethnic lines.

Smith v. Wayne (1925)

 Justified eugenics as an exercise of state police power "based on the growing belief that, due to the alarming number of degenerates, criminals, feebleminded, and insane, our race is facing the greatest peril of all time"

Buck v. Bell (1927)

- In a 1-8 decision, the Supreme Court approved the constitutionality of forced, compulsory sterilization.
- Carrie Buck, accused of having a feebleminded mother and daughter, was involuntarily sterilized.
- "[...] society can prevent those who are manifestly unfit from continuing their kind. The principle that sustains compulsory vaccination is broad enough to cover cutting the Fallopian tubes. Three generations of imbeciles are enough" -Justice Oliver Wendell
- This decision propelled the Eugenics Movement. By 1933, 28 states adopted compulsory sterilization laws.

Roe v. Wade (1973)

- Ruled that restrictive regulation and criminalization of abortion is unconstitutional
- While this case is celebrated as a landmark for women's rights, its roots are deeply racist and engenir
- "At the time Roe was decided, there was concern
 about growth in populations and particularly growth in
 populations that we don't want to have too many of.
 So that Roe was going to be then set up for Medicaid
 funding of abortion" -Justice Ginsburg

Margaret Sanger (1879-1966),

- Known for founding the Birth Control movement and organizations that later became the Planned

 Parenthood Enderston of America

 Parenthood Enderston of America
- Rallied support for social policy in favor of reproductive rights by weaponizing birth control methods as tools for racial eugenics.
 - Presented this method in a speech to the KKK.

"There are few better examples of the interplay of race and law and the ways our preconceptions about race get naturalized as biological fact and inscribed in social policy. No matter that the theory was so glaringly defective as science [...] it formed the basis for eugenics policies, immigration restrictions, and criminal justice practices for decades[...]" -Kitty Calavita

CONTEMPORARY, DOMESTIC EXAMPLES OF EUGENICS

Setween 1997 and 2011, approximately 250 female nmates were sterilized in **California** prisons. At east 39 inmates did not consent, however that maher is

ikely to be larger, and it has also been argued that nformed consent in a prison setting is almost mpossible due to the severe disparity of power ound within an inmate-prison staff dynamic.

Offenders in Tennessee were offered 30-day sentence reductions if they agreed to a vasectomy or sentence reductions if they agreed to a vasectomy or birth-control implant in 2017. These reduction offers ollowed plea deals made in Nashville between 2010 and 2015 involving permanent sterilizations as a prerequisite for inmates' parole or early release. Contemporary examples of eugenics at the hands of the U.S. government can be found outside of prisons nside ICE detention facilities. As of November, 2020 57 detainees held in the Irwin County Detention Center in Ocilla, Georgia have spoken out on their experiences of being urged to submit to unnecessary synecological surgeries. One woman described a hysterectomy for which she was not anesthetized. Many women reported being told by medical staff only that their procedures were necessary, without

In each of the settings described above, most patient undergoing these procedures come from marginalized communities, a fact that only solidifies the claim that these are blatant instances of eugenics. The only reason we have data on these violences in the first place is either because of female offenders who were brave enough to speak out, also having access to lawyers willing to advocate for them, or because a whistle blower reported these medical abuses. Knowing that these truths being uncovered are exceptions, it can be assumed that in states where inmates don't have legal support to report their experiences, these coerced sterilizations and birth control implementations continue.
