d) Youth Smoking

faculty Chyke Doubeni, MD and Linda Cragin, MS and they issued an 11-page report in March, 2008, which is included in the Appendix. It included recommendations regarding leadership commitment, orientation, feedback within a learning environment, advisors, mentors, and psychosocial support and wellbeing. ... We have shared our experiences with other departments and programs, and the institutional response has been supportive. The Equal Opportunity and Diversity Office is working to establish an office based at the Memorial campus. Chyke Doubeni has presented an overview of the situation to the hospital's residency program directors, and will be presenting it to the Dean and Chancellor later this fall."
