### **Teaching Experience**

Am a tenure track Assistant Professor in Child, Youth and Family Studies in the Portland State University School of Social Work. Have been a full-time Assistant Professor of Practice at Portland State University from 2012-2016 in the Departments of Black Studies, Conflict Resolution, and Women Gender and Sexuality Studies. From September 2007- August 2012, taught at Portland State University as an adjunct instructor in the Departments of Conflict Resolution, Women Gender and Sexuality Studies, and University Studies. From January 2012 through January 2013 held adjunct appointments at Portland Community College in Political Science and Women's Studies.
