Clinical Associate Professor of Health Policy and Management and Director of the Center for Rural Health and Research of the Jiann-Ping Hsu College of Public Health of Georgia Southern University. Primary teaching areas are health policy, systems, administration, law and finance. Primary instructional areas include public health administration, health finance, health systems, cancer and society, and health policy, coverage and access. Serve on and chair master's thesis committees, and serve as liaison to the Georgia State University College of Law.

In addition to teaching and research responsibilities, served as a consultant to a not-for-profit community organization (Diversity Health Center, Inc.) which operates two primary care centers in underserved rural areas of Southeast Georgia; both centers are located in the Coastal Health District and coordinate their services and activities with local health departments. Also served as a consultant to the Liberty County Health Department in an effort to develop a regional health system plan for a three county service area and seek external funding for operations. The area's health problems are compounded by proximity to Ft. Stewart, the largest Army post east of the Mississippi.

Founder and President of the Georgia Cancer Coalition, a nonprofit organization headquartered in Atlanta. Began and led the public/private partnership directing the state's comprehensive initiative to improve cancer detection, treatment and research, and to develop a statewide network of cancer care. The Coalition fostered the development of nine regional cancer programs, the recruitment of more than sixty distinguished cancer scholars, provided support for two statewide cancer centers of excellence, and fully funded a cancer state aid program. In addition, screening, education, anti-tobacco and outreach programs were expanded across the state, a statewide cancer clinical trials organization was developed in conjunction with the Georgia Society of Clinical Oncology, and Medicaid coverage was made available to uninsured low-income women who had been diagnosed with breast or cervical cancer. Medical and health profession oncology

education programs were initiated or expanded, and direct support was provided to a large number of cancer survivor and advocacy organizations. Primary funding for the Coalition came from the state's allocation of the Tobacco Master Settlement Agreement, and the GCC was responsible for the development and administration of grants funded from the Settlement Agreement. As President and CEO, reported to both the organization's nonprofit board and the Governor. Liaison with the university and medical communities was critical to success in the job.

First Commissioner of the new department created in 1999. Was responsible for directing the consolidation of state agencies involved in the purchasing, planning and regulation of health care in the state, and managing the department of more than 500 employees. Department components included the divisions of Medical Assistance (Medicaid and PeachCare, Georgia's SCHIP program), Health Planning, Public Employee Health Benefits, the offices of Minority Health, Women's Health, and Rural Health Services, and the three boards responsible for physician licensing and medical education.
