- ❖ **Globalization and Law** (2007, 2008, 2009): First year perspective option course designed to provide a survey of key aspects of international economic institutions and various transnational legal regimes. High enrollment (between 50-78 students).
- ❖ **Law and Social Change: Law and Development** (2008, 2009, 2013, 2014): Upper year course developed and substantially revised/updated each time it is taught; incorporates use of a 'case study' approach to introduce students to complex issues relating to legal reform efforts in developing countries.
- ❖ **Property Law** (2009) First year course co-taught with Stepan Wood.
- ❖ **Law and Film** (2014, 2015) Proposed and developed new curricular offering for upper year students. First taught in January 2014. Students write a major paper on a topic in the field of law and the humanities.
- ❖ **Graduate Reading Group: Law in a Global Context** (2006, 2007, 2008). An advanced, full year, graduate reading seminar engaging with current legal and interdisciplinary scholarship relating to globalization, transnational constitutionalism, international economic law, and international legal theory. Readings are completely updated each year.
- ❖ **Graduate Seminar** (2012, 2013, 2014, 2015, 2016) The foundational course for entering graduate students, both masters and doctoral, in the Osgoode Research stream graduate program. Originally designed by Prof. Liora Salter as a proposal-writing workshop, involving weekly feedback on short writing assignments. I co-taught this course with Prof Salter in 2012, and then redesigned it to incorporate additional readings on theory and methodology in 2013.
