

- Stuff of history
















Archives are made up of lots of different physical and digital formats:

Papers, electronic records, photographs, audio recordings, film

Created by or come from individuals, families, or organizations as they go about their daily lives and work

That have historical value


## What is "Historical Value?"

- Created for a primary purpose
- "Eye-witness accounts" of current events, people, and locations










Examples of documents created for a primary purpose but that can have secondary purpose: newspaper, letter, home movies; same for documents in digital formats.




Eyewitness accounts!

- Enable democracy through open/transparent records














Physical and intangible attributes of a group or a society that the current generation inherits from past generations.



#### Biography => Frank L. McVey papers

- UK president 1917-1940
- (1869-1953)
- What in the collection is used for research:
  - · Correspondence and memoranda
  - Speeches, reports
  - Newspaper clippings
- Research topics: biography, development of the university and higher education in Kentucky, political controversies





The University of Kentucky. Office of the President: Frank LeRond McVey papers (dated 1880-2012; 97.49 cubic feet, 57 record storage cartons, 82 document boxes, 36 photograph boxes, 27 oversize boxes, 1 wrapped item) comprise correspondence and memoranda, reports, writings and speeches, notes, subject files and newspaper clippings, diaries, and photographs documenting Frank L. McVey's professional and personal life, including as presidents of the University of North Dakota and University of Kentucky.

## Frazier Kentucky History Museum exhibit => Ben Reeves Collection

• Ben Reeves (1947-2014) was a teacher in the Garrard County School System, the librarian at Garrard County High School, and an employee of the Central Record newspaper.


• What in the collection is used for exhibit:

• Buttons, game tickets, scrapbook

• Research topics: Kentucky Rivalries, sports in society







The Ben Reeves Artifacts and Memorabilia Collection on University of Kentucky Athletics (1962-2013, undated; 8.5 cubic feet; 12 boxes, 1 folder, and 1 tube) comprises primarily three-dimensional objects, photograph albums, and videocassette tapes documenting the play, publicity, and marketing of the individual athletes, games, and tournaments of the University of Kentucky football and men's basketball teams from the mid-20th century through the early 21st century.

## Lexington organizations=> Abby Marlatt papers

- Abby Marlatt (1916-2010) was a UK home economics faculty member (1956-1985) and a human rights and social justice activist and volunteer
- What in the collection is used for research:
  - League of Women Voters, 1945-2007
  - Micro-City Government, 1968-1999, 2007
  - Congress of Racial Equality (CORE) Lexington chapter, 1947-1981
- Research topics: civil rights movement, history of St. Paul African Methodist Church, busing exhibit



The Abby Marlatt papers (dated 1945-2007, undated; 42.38 cubic feet, 41 record storage cartons, 1 document box, and 2 flat boxes) comprise University of Kentucky and Lexington, Kentucky-related papers of Human and Environmental Sciences professor Abby Marlatt, primarily from 1959-2007. Collection consists of the files of progressive and social justice organizations in which she was involved, usually as a volunteer (22 boxes); personal correspondence, honors, and awards, including her life with her partner, Norma Perry (10 boxes and 2 oversize boxes); academics/courses taken (2 boxes); Lexington open housing and Congress of Racial Equality files (CORE), 1940s-1970s (5 boxes); and personal photographs and slides (2 boxes).

## Lexington landscape=> Johanna Rice van Outer family scrapbooks

- Johanna Rice van Outer (1911-2006) and her family lived in Clifton Heights neighborhood
- What in the collection is used for research:
  - Snapshots of the van Outer home and neighborhood
- Research topic: urban development of Lexington over time, especially around the university
- Used in conjunction with many other collections







The Johanna Rice van Outer scrapbooks contain photographs, newspaper clippings, marriage certificates, birth certificates, death certificates, school certificates, a naturalization certificate, deeds, and wills pertaining to the van Outer family. The materials pertain primarily to Johanna van Dort van Outer (Johanna Rice's mother), Cornelis van Outer (Johanna Rice's father), Cornelis van Outer (Oldest son), Johanna (van Outer) Rice, and Henry van Outer (Youngest son). The family lived in the Clifton Park neighborhood which is the area that the Young Library (University of Kentucky) is now located. The content came from one small scrap book which contained newspaper clippings and items #1-30; and 1 large scrap book which contained everything from item #31 forward. The photographs are casual snapshots of the family and their life. The descriptions contained within quotation marks were taken directly from the pictures.


Two example photographs from the van Outer family scrapbooks, around 1918. Photo on left from the Edward Louis Nollau Nitrate Photographic Prints, 1919.

## 1918 flu pandemic personal recollection=> Hester Hollingshead letters

- Hester Hollingshead (1898-1983) was in college and far away from her family in 1918-1919
- What in the collection is used for research: Letters
- Research Topic: personal impact of influenza pandemic
- Outreach Topic: explaining our "In This Together" project
- Used on conjunction with many other collections
- Part of the Wade Hall Collection of American Letters

The Hester Hollingshead letters (dated 1918-1919; 0.15 cubic feet; 4 folders) comprise correspondence from her mother and father in Boise, Idaho, sent to her while she was attending Smith College in Northampton, Massachusetts. The letters primarily discuss the Spanish influenza outbreak and the end of World War I, including quarantines, restrictions on activities, inoculations, and the possibility of Americans with German sympathies aiding in the spread of the Spanish flu. Also included are a few letters revealing romantic friendships between Hester and former college roommates.


The Hester Hollingshead letters are part of the Wade Hall Collection of American letters, which includes correspondence and diaries from all over North America covering the time period of the Civil to Korean Wars. The materials were collected by Wade Hall and document everyday men and women.



Example letter from Mary (I think a sister) to Hester dated December 2, 1918.


Left: "Mother saw Mrs. MacArthur today and she said you were in strict quarantine again. I certainly am sorry and hope they don't have many cases although it must be getting pretty bad. Are you quaranteened by houses."

Right: "Schools here opened today, but so few attended and the epidemic is still bad so they are considerating closing again soon. Marguerite says the schools in Middleton are not going to open for a week yet and probably not until the first of the year. They get their pay and do not have to make up their time. Some job?"



## Football documentaries=> University of Kentucky coaching film

- University of Kentucky coaching film, 1940s-1980s
  - Shot from the press box
  - To analyze game play
- Research Topic: Stories of individual athletes and highs and lows of the sport in the state and the South









## UK SCRC Collecting Policy



The Special Collections
Research Center collects,
preserves, and provides
access to materials
documenting the social,
cultural, economic, and
political history of the
Commonwealth of Kentucky.



The collecting repository exists to document a theme external to the organization that established the repository. That theme is usually based in geography, a subject, a specific event, individual, group, or era, or format.

The second type is the institutional archives, which exist to document their parent organization.

The third type is the hybrid repositories, which exist to document their parent organization and an external theme or themes.



#### Collecting Repository example:

- Elna Nielsen Smith Melvin (1903-1992)
- 5 boxes => Danish American Archive and Library, Blair, NE









For example, we found 5 boxes under Abby's bed that turned out to be papers of Elna Smith Melvin, a friend of Abby's from the Unitarian Universalist Church. Elna was born in 1903 in Chicago, Illinois, to Danish-American parents, grew up in Blair, NE, and attended high school and college in Blair before receiving an English degree in 1925 from the University of Nebraska. She was married twice, married twice, did graduate and research work for various US governmental organizations in sociology and anthropology, and traveled and lived across the US and Korea and Japan. She landed in Kentucky in 1965. Elna was estranged from her children and grandchildren and Abby served as her executor. Elna and Abby had kept things like personal and academic correspondence, photographs, and Masonic objects. Turns out there's an archives in Blair, NE, that documents the experiences of all Danish Americans and their descendants, so this collection was a great fit for them.

#### Hybrid Repository example:

- Bryan family, Balineen-Enniskean, County Cork, Ireland
- 39, 8mm, home movies, 1961-1970 => Cork City and County Archives





The home movies taken by my father's aunt, Emily Frances Bryan, a nurse in the British Army. Seem to be primarily of family gatherings, events, or holidays in Ireland (with one trip to Scotland), although there are also some of her work in Cowglen Military Hospital and in Ghana.

"Cork City and County Archives is responsible for preserving local archives from Cork city and county. Under the local government acts, it is a statutory function of the Council to acquire local archives, to ensure their proper management, custody, care and preservation, and to make them available for public research and inspection. Local archives includes local government records of enduring value, and deposited archives acquired by purchase, donation, bequest or loan."

#### Hybrid Repository example:

- Carole Honstead Gnatuk
- 11 boxes/crates, 1942-2015 => Kansas State University Richard L. D. and Marjorie J. Morse Department of Special Collections





Mom's collection includes scrapbooks she kept from first grade through her early married life; letters she wrote to her mother while she and our family were living in Venezuela and Spain; and writings, presentations, evaluations, reports, and research material from her work as an extension specialist at Eastern KY University and the University of Kentucky. Mom was raised in Manhattan, Kansas, and attended Kansas State University for her bachelor's degree.


K-State's Special Collections collects and preserves the K-State's institutional records, the department also serves as a vital epicenter for research pertaining to the consumer movement, cookery, Kansas culture and K-State history. #### **Typical Donation Process**



Sign a **donation** form

**Selection** by archivists/librarians/ curators



Get the memorabilia to the archives

These steps can happen in any order:


Signing a donation form: transfers ownership in property from you to the archives. Can be done in person or by mail. Photo is of Carole Gnatuk with Mary Ellen Ducey at the University of Nebraska Lincoln Archives and Special Collections in 2019.

Getting the memorabilia to the archives. In person, by mail or shipping.

Selection and decision-making by archivists, librarians, and curators. Photo is of Linda Glasgow and Corina Hugo at the Riley County Historical Society in 2017. Typically, museums and archives and libraries have different procedures.

## What Happens After Donation?

- Accessioning: basic physical and intellectual "control"
- Processing (prioritization): detailed preservation and description
- Create a "collection guide" or "finding aid"




## How Do Researchers Find Stuff (the stuff of history)?
